The Ethics of Cultural Competence: Introspection, Insight, & Intention Serving our consumers and clients from a place of cultural competence is an ethical requirement and, ideally, a personal mandate as well. Yet we often approach cultural competence from a frame of avoiding offense. Taking this approach often limits our capacity to actually engage effectively with people who are different from us. When we instead approach cultural competence from the perspective of understanding our own cultural background, recognizing our knowledge limitations about other cultures, and taking a proactive approach to expanding our knowledge, we can become exponentially more culturally competent and meet the spirit and the words of our ethical codes. In this training, participants will dig into cultural competence through creative, tangible, and practical methods and will leave with tools for better engagement with seniors and other populations they serve.

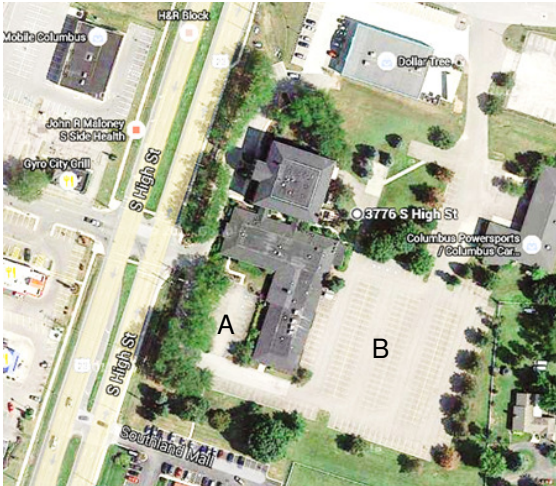
